Achieved VET units of competency	<p>For the previous calendar year, the number of school-aged students who left the school and who during their secondary schooling had successfully completed at least one Unit of Competency as part of a VET qualification at AQF Certificate II or above.</p> <ul style="list-style-type: none"> • The data provided in this section shows the level and range of VET activity at an individual school.
